ORDINANCE NO. 2018-06

AN ORDINANCE OF THE TOWN COMMISSION OF THE TOWN OF HILLSBORO BEACH, FLORIDA, AMENDING THE TOWN'S CODE OF ORDINANCES BY AMENDING CHAPTER 7 ENTITLED THE "OFFENSES AND MISCELLANEOUS PROVISIONS", SPECIFICALLY AMENDING ARTICLE II ENTITLED "PARKING OR STORAGE OF VEHICLES" BY CREATING SECTION 7-20 TO BE ENTITLED "JUNK/DEAD STORAGE OF VEHICLES"; PROVIDING FOR ADDRESSING AESTHETIC ISSUES THAT AFFECT THE QUALITY OF LIFE OF ITS RESIDENTS; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; PROVIDING FOR CODIFICATION; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town Commission has determined that it is in the Town's best interest to address aesthetic issues that affect the quality of life of its residents: and

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN OF HILLSBORO BEACH, FLORIDA THAT:

**Section 1.** The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and is hereby made a part of this Ordinance.

**Section 2.** Chapter 7 of the Code of Ordinances is hereby amended by specifically creating Section 7-20 to be entitled "*Junk Dead Storage of Vehicles*" which shall read as follows:

**Section 7-20.- Junk/Dead Storage of Vehicles.**

**It shall be unlawful to park, store, or leave for a length of time not to exceed twenty-four (24) hours, any vehicle of any kind, in an abandoned, wrecked, junked, discarded, dismantled condition, or without a current valid license plates in or on the vehicle which can be viewed from outside the vehicle on public rights-of-way or other public or privately owned property.**

**Section 3.** If any section, subsection, sentence, clause or provision of this Ordinance is held invalid, the remainder of this Ordinance shall not be affected by such invalidity.

**Section 4.** That all ordinances or parts of ordinances and all resolutions or parts of resolutions in conflict with this Ordinance are repealed to the extent of such conflict.

**Section 5.** It is the intention of the Town Commission of the Town of Hillsboro Beach, that the provisions of this Ordinance shall become and be made a part of the Code of Ordinances of Town of Hillsboro Beach, Florida, and the Sections of this ordinance may be renumbered, re-lettered and the word "Ordinance" may be changed to "Section," "Article," or such other word or phrase in order to accomplish such intention.

**Section 6.** This Ordinance shall be effective fifteen (15) days after its passage and adoption by the Town Commission of the Town of Hillsboro Beach.
